Permission Under Sub-Section (3) of the Section-16 of the Orissa Development Authorities Act'1982(Odisha Act, 1982) is hereby granted in favour of **Sri. Sambit Sunil Srichandan**, through GPA holder GK DEVELOPER, represented by its Proprietor Sri Amresh Parida, for construction of **S+4** storey Residential Apartment building over G.A-Plot No-637 ,corresponding to Revenue Plot No-4/9855, Drawing Plot No-637, Drg No-B/132, Khata No-611/3709 , Mouza- Chandrasekharapur, under Bhubaneswar Municipal Corporation in the Development Plan area of Bhubaneswar with the following parameters and conditions;

- The building shall be used exclusively for **Residential** purpose and the use shall not be changed to any other use without prior approval of this Authority.
- The development shall be undertaken strictly according to plans enclosed with necessary permission endorsement.
- Parking space measuring **289.49 Sqm** as shown in the approved plan shall be left for parking of vehicles and no part of it will be used for any other purpose and shall not be partitioned/closed in any manne.
- The land over which construction is proposed is accessible by an approved means of access of **60.97 M (Six Zero point Nine Seven)** in width.
- The land in question must be in lawful ownership and peaceful possession of the applicant.
- The permission granted under these regulations shall remain valid up to three years from the date of issue .However the permission shall have to be revalidated before the expiry of the

above period on payment of such fee as may be prescribed under rules and such revalidation shall be valid for one year.

8. (i) Approval of plans and acceptance of any statement or document pertaining to such plan shall not exempt the owner or person or persons under whose supervision the building is constructed from their responsibilities imposed under BDA (Planning & Building Standards) Regulations, or under any other law for the time being in force.
- (ii) Approval of plan would mean granting of permission to construct under these regulations in force only and shall not mean among other things;
 - (a) The title over the land or building;
 - (b) Easement rights;
 - (c) variation in area from recorded area of a plot or a building;
 - (d) Structural stability
 - (e) Workmanship and soundness of materials used in the construction of the buildings
 - (f) Quality of building services and amenities in the construction of the building,
 - (g) the site/area liable to flooding as a result of not taking proper drainage arrangement as per the natural lay of the land, etc and
 - (h) Other requirements or licenses or clearances required to be obtained for the site /premises or activity under various other laws.
9. In case of any dispute arising out of land record or in respect of right, title, interest after this permission is granted, the permission so granted shall be treated as automatically cancelled during the period of dispute.
10. Neither granting of the permit nor the approval of the drawing and specifications, nor inspections made by the Authority during erection of the building shall in any way relieve the owner of such building from full responsibility for carrying out the work in accordance with the requirements of NBC 2005 and these regulations.
11. **The owner /applicant shall;**
 - (a) Permit the Authority to enter the building or premises, for which the permission has been granted at any reasonable time for the purpose of enforcing the regulations;
 - (b) Obtain, wherever applicable, from the competent Authority permissions/clearance required in connection with the proposed work;
 - (c) Obtain an Occupancy Certificate from the Authority prior to occupation of building in full or part.
 - (e) Register the said Apartment project over scheduled property under the Real Estate (Regulation & Development)-Act-2016.
12. Wherever tests of any material are made to ensure conformity of the requirements of the regulations in force, records of the test data shall be kept available for inspection during the construction of building and for such period thereafter as required by the Authority.
13. The persons to whom a permit is issued during construction shall keep pasted in a conspicuous place on the property in respect of which the permit was issued;
 - (a) A copy of the building permit; and
 - (b) A copy of approved drawings and specifications.
- I) If the Authority finds at any stage that the construction is not being carried in accordance to the sanctioned plan or is in violation of any of the provisions of these regulations, it shall notify the

owner and no further construction shall be allowed until necessary corrections in the plan are made and the corrected plan is approved.

15. This permission is accorded on deposit /submission of the following:

IV) 20% of the parking space in the apartment building shall be exclusively earmarked for visitors with signage as per norms under Regulation-37(10) of BDA (Planning & Building Standards) Regulations'2018.

V) Plantation as required under the provision under regulation 29 of BDA (Planning & Building Standards) Regulations'2018. shall be strictly adhered.

VI) The Owner/ Applicant/Architect/Structural Engineer are fully and jointly responsible for any structural failure of building due to any earthquake/cyclone/any other natural disaster, structural/construction defects, Authority will be no way be held responsible for the same in what so ever manner.

VII) The concerned Architect / Applicant / Developer are fully responsible for any deviations additions & alternations beyond approved plan/ defective construction etc. shall be liable for action as per the provisions of the Regulation.

VIII) The applicant shall comply to the infrastructural specification and subsequent clearance with regard to development of infrastructure from BMC before occupancy.
